AGREEMENT

THE UNDERSIGNED IN CONSIDERATION OF BEING ALLOWED BY HIS MAJESTY PASSAGE THROUGH OR USE OF THOSE CANALS OF THE DOMINION OF CANADA ON THE ROUTE OF THE SAID VOYAGE, AGREES THAT SUCH PASSAGE OR USE SHALL BE MADE SUBJECT TO THE CURRENT RULES AND REGULATIONS IN FORCE, APPROVED BY THE GOVERNOR IN COUNCIL, AND TO ALL THE FINES, PENALTIES, CONDITIONS AND LIABILITIES IMPOSED THEREBY FOR THE INFRACTION THEREOF, AND FURTHER AGREES TO COMPLY WITH AND ABIDE BY ALL THE PROVISIONS IN SUCH REGULATIONS, AND, FORTHWITH ON DEMAND TO PAY AND DISCHARGE ALL DUES, FINES, PENALTIES AND LIABILITIES UNDER SUCH REGULATIONS, AND, IN DEFAULT, THAT SUCH ACTION MAY BE TAKEN BY AND ON BEHALF OF HIS MAJESTY AS PROVIDED FOR IN SUCH REGULATIONS TO ENFORCE COMPLIANCE THEREWITH, AND TO GIVE EFFECT TO THE SAID, AND FOR THE RECOVERY OF ALL SUCH DUES, FINES, PENALTIES AND LIABILITIES SO IMPOSED, AND FURTHER AGREES TO MAKE NO CLAIM OR DEMAND FOR THE RECOVERY OF ANY SUCH DUES, FINES, PENALTIES OR LIABILITIES OR TO SUSTAIN OR DEFEND IN A COURT OF LAW OR EQUITY OR OTHERWISE BY THE SAID VESSEL, OR ITS CREW, OR PASSENGERS THROUGH THE SAID CANALS OR ANY OF THEM, CAUSED BY OR RESULTING FROM THE NEGLIGENCE OR ANY OFFICER OR SERVANT OF HIS MAJESTY WHILE ACTING WITHIN THE SCOPE OF HIS DUTIES OR EMPLOYMENT ON SAID CANALS OR ANY OF THEM.

THE UNDERSIGNED IN CONSIDERATION OF BEING ALLOWED BY HIS MAJESTY PASSAGE THROUGH OR USE OF THOSE CANALS OF THE DOMINION OF CANADA ON THE ROUTE OF THE SAID VOYAGE, AGREES THAT SUCH PASSAGE OR USE SHALL BE MADE SUBJECT TO THE CURRENT RULES AND REGULATIONS IN FORCE, APPROVED BY THE GOVERNOR IN COUNCIL, AND TO ALL THE FINES, PENALTIES, CONDITIONS AND LIABILITIES IMPOSED THEREBY FOR THE INFRACTION THEREOF, AND FURTHER AGREES TO COMPLY WITH AND ABIDE BY ALL THE PROVISIONS IN SUCH REGULATIONS, AND, FORTHWITH ON DEMAND TO PAY AND DISCHARGE ALL DUES, FINES, PENALTIES AND LIABILITIES UNDER SUCH REGULATIONS, AND, IN DEFAULT, THAT SUCH ACTION MAY BE TAKEN BY AND ON BEHALF OF HIS MAJESTY AS PROVIDED FOR IN SUCH REGULATIONS TO ENFORCE COMPLIANCE THEREWITH, AND TO GIVE EFFECT TO THE SAID, AND FOR THE RECOVERY OF ALL SUCH DUES, FINES, PENALTIES AND LIABILITIES SO IMPOSED, AND FURTHER AGREES TO MAKE NO CLAIM OR DEMAND FOR THE RECOVERY OF ANY SUCH DUES, FINES, PENALTIES OR LIABILITIES OR TO SUSTAIN OR DEFEND IN A COURT OF LAW OR EQUITY OR OTHERWISE BY THE SAID VESSEL, OR ITS CREW, OR PASSENGERS THROUGH THE SAID CANALS OR ANY OF THEM, CAUSED BY OR RESULTING FROM THE NEGLIGENCE OR ANY OFFICER OR SERVANT OF HIS MAJESTY WHILE ACTING WITHIN THE SCOPE OF HIS DUTIES OR EMPLOYMENT ON SAID CANALS OR ANY OF THEM.
