EVENT REGISTRATION NUMBER

To obtain an ERN number, simply do the following:

- Send a photocopy of the dog's registration certificate reflecting current ownership with a written request for an ERN number. Include payment in full (\$57.75 including GST)
- Include a cheque, money order or credit card authorization for the full amount. Payment may be made with a personal or business cheque, money order, VISA or MasterCard. Non members please note that if paying by cheque, the cheque must be certified. Non residents of Canada please note that discounted cheques or money orders will not be accepted due to fluctuating currency rates.
- Provide a full return address.
- Faxed requests will be accepted. Please ensure your Visa or MasterCard number is legible and you have included your expiry date and signature.

An ERN must be obtained within 30 days of obtaining points, awards, or scores to avoid cancellation. If factors beyond your control prohibit this or present a problem, please send a written request for a 30 day extension to: The Canadian Kennel Club, Shows & Trials Division, 200 Ronson Drive, Suite 400, Etobicoke, ON M9W 5Z9. TRIAL RULES AND GENERAL INFORMATION

- No entry will be accepted unless all particulars called for on the entry form are completed in full. Handlers or agents please note the full name and address of all owners must be filled in.
- Incomplete entries will be returned. No entry will be accepted unless accompanied by entry fees. Telephone, e-mail and fax entries cannot be accepted.
- The club reserves the right to remove any person from the Show. The Trial Committee shall have full control of the shows & trials, which will be governed by CKC RULES.
- The show committee will use due care and diligence for the welfare of dogs and exhibitors, but will not be responsible for, or assume any liability in the event of accident, or other misfortune to either dogs, exhibitors or patrons.
- Exhibitors are solely responsible for the conduct or actions of their animals while they are on the Show grounds.
- The owner of dogs entered in these shows is entirely responsible for any error in entering dogs, regardless of how or by whom the entry was made.
- For the benefit of the health of animals and the pleasure of exhibitors and spectators we insist upon keeping the grounds as clean as possible. Exhibitors are responsible for cleaning up after their dogs. Please exercise your dog BEFORE taking it to the ring.
- Dogs must be exercised in DESIGNATED AREAS ONLY, not in the ring areas.
- If because of riot, civil disturbance or other acts beyond control of the Club, it is impossible to open or complete the show, no refund of entry fees will be made.
- IT WILL BE THE SOLE RESPONSIBILITY OF THE EXHIBITORS TO HAVE THEIR DOGS AT RINGSIDE when necessary. There will be no paging of individual dogs.
- Dogs must be on leashes at all times on the show grounds or in the show building with the exception of the Rally-Obedience rings.
- Exhibitors are responsible for their children while at the show and will be held accountable for any damages caused by children playing unattended
- The entire show site is designated as NO SMOKING.
- Bitches in season are not permitted to compete or be in the show building during the trials. If bitches come into season after the closing date, a veterinarian's certificate, stating that the bitch was in season within the ten day period before the trial must be in the Trial Secretary's hands before the start of that day's trial, in order to obtain a refund of entry fees.
- All entries must be typed or distinctly printed. Owners are responsible for errors on the entry forms. The OVPC does not assume any responsibility for incorrect information or for errors due to illegibility of information on an entry submitted by the owner or agent, or for entering a dog in a class in which the dog is not eligible to enter or compete. Entries must be signed by the owner or agent or the entry will be rejected.

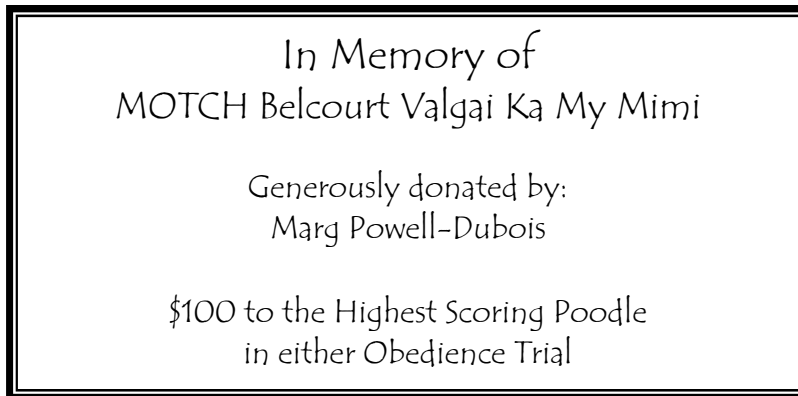

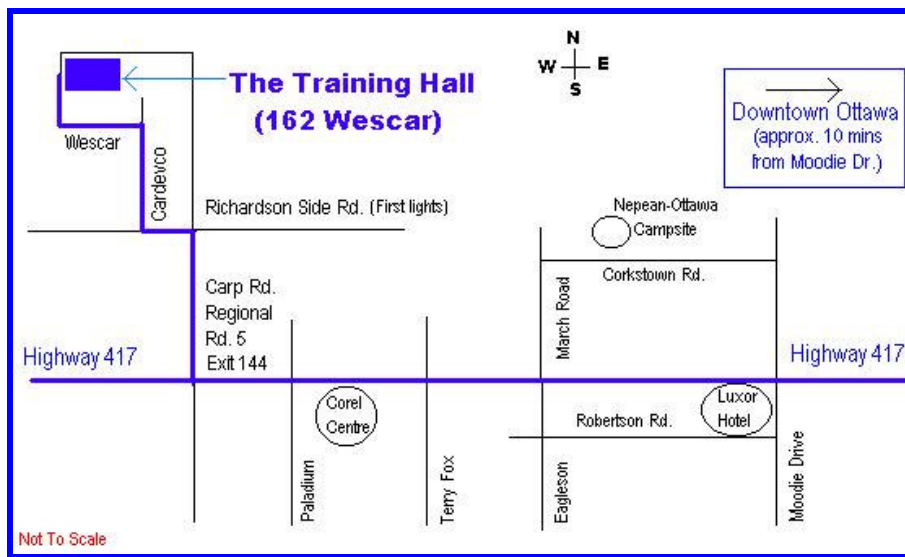


- A qualifying ribbon will be awarded to all dogs obtaining a qualifying score.

Note: Fees must accompany entries. Tendering of an NSF cheque shall be considered Non-Payment of Entry and is an offence punishable by disciplinary action and cancel of awards by CKC. There will be a \$20.00 charge for NSF cheques refused or declined. Post-dated cheques will not be accepted. Overpayment of entry fees will not be refunded. We will accept one entry form per dog for all shows, or for all trials.

ATTENTION FOREIGN EXHIBITORS

Please note that fees are due and payable in Canadian dollars. Due to consistently fluctuating currency rates, discounted cheques will not be accepted. Personal cheques will be accepted, however, they are to be payable in Canadian funds. If you send a cheque in US funds, it must be made out for the full amount of the entry and no exchange will be refunded to the exhibitor. Please do not mark cheques "Payable in Canadian Funds" or "At Par". They will not be cleared by the banks. To simplify the process, we urge that you purchase bank drafts or money orders payable in Canadian Funds.
