Thank you for inviting us to be part of your team for Mechanical & Electrical Building Engineering Services. We are pleased to submit our Fee Proposal as follows:

#### 1.0 PROJECT UNDERSTANDING

1.1 Evaluate the existing heating systems for the building to determine the viability of converting from all electric to all gas heating. The systems include a building make up air system including a Q-Dot heat recovery unit, a garage ventilation system including a proposed CO monitoring system, and an existing 2 pipe chilled water fan coil system in each suit switch to heating in the winter.

The scope shall include:

- 1. Review the maintenance records for all systems (supplied by owner).
- 2. Review the utility bills for the past 5 years (supplied by owner).
- 3. Interview with the building operator.
- 4. Perform a cost benefit analysis to convert the systems to gas heating.
- 5. Provide preliminary written report describing recommendations.
- 6. Meet with the Owner to review the recommendations and answer any questions.
- 7. Provide final report.

Based on the above we offer our engineering services for a fee of \$4,000.00. HST is not included in this value and will be charged in addition.

### 2.0 ENGINEERING CONTRACT
