Company of Canadians 2022 National Invitation to Organizers

Our planet is dying. Our lives are in trouble. Income extremists aiming for global domination intend to own and plunder all our natural resources and control every essential human need and action. Accurate assessments of the state of the world reveal not just a climate being pushed beyond stability, but farms, forests and fisheries worn thin. We exceeded the capacity of the planet to sustain our lives in about 1987. The situation is not good and nothing significant is being done about it, primarily because it would upset richest people in the world. Little attention is being paid to the essentials of life, such as the fact that our lives and the economy rely utterly on the provisions of Nature.

In Canada (considering one problem of many example), personal and national food security is not even recognized as the basis of national security, and instead those seeking complete control of food and money have attacked farming and acted to impede individuals from working with others to grow food. Food then becomes unaffordable relative to wages, and healthy food along with access to land to grow food is denied to those starting life with little, this generation. With our global ecosystems pushed to the limit, income extremists are once again turning on people to maintain their fantasies of unlimited exponential growth with all profit directed to a few seeking massive income without labour. There is more to life than that, and quite frankly life under corporate rule is a crashing bore.

Now things are so bad that we need an effort at the scale of a world war to turn things around and save this generation of Canadian kids from the worst effects of local to global catastrophe. But those that benefit from the plunder are not interested. Here, we take a good hard look at the World Scientists' warning to Humanity and related IPCC reports created by the top minds and the planet also laying out a plan of action showing what we need to do. This is the question of how to best relate to others and the ecosystems that sustain our lives as the sole basis of our economy. We also take along hard look at the law, what it is and what it should be, and our inherent rights, freedoms and responsibilities to act in the smartest safest direction possible. The relationships between government services and those that pay for it all. We find in this much we can do, but considering the scale of action required find that the best course of action may be to create a company all Canadians can join dedicated to the cause of going green and protecting this generation in all areas of work and human needs. To do this in cooperation with government is most simply done by accepting the Canadian Charter of Rights and Freedoms as our Company Charter and adding to it the rights needed to determine a self-sufficient sustainable future. This is our first test. If we fail in this task, this generation of young Canadians faces a hellish future in which the odds of their survival are low. We cannot go that route.

The specific freedoms denied in our Canadian Charter are the social and economic rights allowing individuals work with one another freely using common resources. When a company forms, a group of individuals pools their assets of time, talents and resources, generally not getting paid until there is enough income to overcome startup expenses. Here, it is important to minimize expenses while finding income-generating work. Only certain types of work allowing one to start small and scale up during development. Lawn and garden care is one example of a business with low initial expenses that depends primarily on outreach. When home gardens include food (as an important example of inclusive

green work needed to gain local food security), we naturally add to this the need to create a permanent pool of work for youth that directly supports the lives of seniors who need help around the house and garden. This is a secure lifelong business plan allowing care across the generations which is both healthy and natural. It is also a business that requires a planned structure, but which is easily developed at a variety of scales and can be implemented everywhere across the country at once.

Accepting the Charter means that any work in our core economy of essential human needs has *Section* 7 Charter protection as a Constitutional Activity. We also accept *Section 1* recognition of provable reasonable limits of the human capacity to do work, with fact and evidence being required to substantiate a natural range of work and a Gaussian distribution of incomes directly related to competency. No one will get rich, but no one will get ripped off or denied work to meet essential needs. Under *Section 15* equality under the law, *j*ust because one person has excellent organization skills does not mean they are placed *above* the person(s) doing the work. It also means that we can be a company composed entirely of owners. Anyone can join the company; the company does not hire people. It can be a company of companies, allowing people to work together freely on all projects and interests - but only in activities supportive of our mutual *Section 7* rights to life, aimed at defending the rights and freedoms of others and ensuring permanent ongoing life security across the generations. This is the significant challenge that defines our times. For the sake of our kids, we cannot fail.

With our ecosystems pushed to their limits, unsustainability now means death. Those that plunder our systems do not care, whereas we find there is a lot we can do to go green. We are a creative species with many solutions. One of our first tasks is to implement the many known solutions. Local production and consumption is critical to stabilizing our economy and consistent with our national priorities. Most of what we buy is not that hard to make, and we have many low-carbon low-energy solutions in wood, paper, plastics and metalworking. We have a deep mine of expired patents with many great old designs in long-lasting low-energy non-electric mechanics. We now have computer design and fabrication programs and internet access to how-to videos. We have barely begun to explore what we can do with internet access to information as an incredible new communications technology. There is much we can do, but we cannot ignore our very real problems and the hard choices we must make in relation to viability of life on this planet. We need new green low-carbon low-energy local minimal-transport work made available to as many people as possible now.

Here, we seek a team of organizers with the diverse skills and knowledge, care and drive to move our country forward by developing and immediately implementing a significant large-scale plan to save this generation of Canadians kids. We will address all human needs economically and in compatible relationship to our natural ecosystems. We will address housing and energy, work and transportation, manufacturing and consumption, education and the creation of healthy social structures in which individuals can grow and thrive. We need 300 such talented caring people fundamentally driven by a sense of parental care and obligation to each upcoming generation.
