

Criminal Negligent Manslaughter, City Hall's Final Solution

On Monday, December 5, 2022, the newly elected Mayor and council of Peterborough described the undesirable characteristics of a group they wanted gone. Decided they had the right to hold the power of life and death over others. And voted to deny reasonable lifesaving shelter to our most vulnerable members of society, permanently snuffing out their last hope for survival.

The Mayor and council have ordered forced death marches and removed lifesaving gear and supplies from those in extreme deprivation. This fits the Criminal Code of Canada Section 318 description of advocating genocide.

Not since World War II have we seen such significant abuses of life, liberty and security of the person, extending to major violations of our Crimes Against Humanity and War Crimes Act. We have bodies rolled up in tarps, others frozen rigid into bags of garbage.

I went undercover to experience firsthand the sheer level of hate and malice directed at anyone without enough money to pay the extreme expenses imposed on them by the Mayor and council and their beneficiaries in banking and business. Though I am trained to put myself in harms way in defence of the lives of the vulnerable, that work took me within inches of death. After a full investigation, having experienced the full scale of outright attacks on life, freedom and the foundations of life security, my only no recourse was to lay down 220 pages of multiple and major criminal code violations

committed by City Hall. Indicting the directors for this massive scale of human rights abuses. The case is now under consideration by the Ontario Court of Justice, under Charter law as a public document available for open reading. Death camps aimed fully at extreme deprivation of essential human needs do not happen by accident.

What we have here is a massive humanitarian disaster zone, one caused fully by City Hall. It can be fixed in a split second, and many groups are prepared to do so, but the Mayor says no. The Mayor has attacked the fundamental freedom and right of every Canadian citizen to make critical decisions about their life by equality under the law. Rejected outright Section 1 of our Constitution Act which distinguishes democracy from authoritarian rule by force. The extent of the crisis, now requiring large-scale UN-style humanitarian relief efforts, cannot be underestimated.

The Mayor has decided that the Canadian land does not belong to the Canadian people and must not be used under any circumstances to secure the Charter-protected core economy of essential human needs based on work, food and shelter. He says Canada is not our home; we have no rights to be here unless we pay him. This is the fundamental right and necessity of having a place to exist, indistinguishable from a right to life.

The direct result? Death on the streets. This is the sentence for anyone, from students to seniors, who cannot afford to pay the extreme life expenses imposed on them by those who believe the sole purpose of land and our lives is to make money for the already-rich who do not want to work for a living and have become a massive burden on society.

The Mayor has signed contracts with these groups aimed explicitly at the removal of rights and freedoms, in particular removing your

Freedom of Association from individuals aiming for complete control every essential human need for unlimited profit.

The Criminal Code Section 59 charge here is Sedition, locally overthrowing our democratic government and replacing it with the working mechanisms of an authoritarian state in which citizens have no say whatsoever about anything that impacts their lives and the future of their children.

The Mayor and council, working against the law and all purposes of legitimate government, have produced land use maps identical to those used in North Korea. Aimed explicitly at stopping people from growing food, stopping free trade, and crushing any form of democracy in which citizens can exert their fundamental freedoms to attain foundational life security by the work they do.

Those on the receiving end of the Mayor's policies experience unmitigated hate from morning to night. They are well aware of systematic force used against them, attacking every essential human need. Programs actively pushing them to death aimed at full removal of any possibility of hope. They know nothing but government against them.

This is not government against people. We have laws. This is a handful of people who have gone rogue. Forming a gang within government claiming without basis the right to rule over the lives of 84 000 residents in fine detail with zero democratic say. Rejecting their sworn duty to defend life, liberty and security of the person, they instead chose at sweeping scale to violate Section 220 and 221, criminal negligence causing death and bodily harm.

As a direct result of their hateful land use policies exhibiting callous disregard and contempt for the lives of local residents. The Mayor fully rejects equality under the law, forgetting that he lives on social assistance.

The critically vulnerable are the tip of the iceberg. The policies of City Hall apply to everyone. From struggling seniors to an entire generation of young Canadians, now unable to even begin to gain a foothold in life, all due to policy. This is not an institute of care. City Hall has actively removed all critical systems of social, ecologic and economic care and is now an institute of oppression operating by force, threat and malice.

City Hall now ranks extremely high in the psychopathy index, exceedingly low in the standards of care consistent with the principles and practices of the Canadian Constitution Act. We never agreed, and we never will agree, to these active attacks on our lives.

No caring parent would ever agree to the plans they have made for our children.

After World War II, major efforts were made to understand the specific personality types that actively aim to undermine, gut and destroy the lives of others.

The average person of healthy mind sees something going on and immediately seeks reason. Always saying there must be a reason, they cannot comprehend the mind of a person whose thoughts are not grounded in physical reality and whose motives are to abuse the lives and rights of others.

We cannot comprehend the thoughts of psychopaths lacking conscience and taking pleasure in toying with and torturing others. Only the mentally ill would cause and create such conditions and refuse to allow others to solve it. Such persons cannot meet the duties of positions of power over others, Section 1 of our Constitution Act requiring reason based on fact and evidence in the context of justice.

Such persons purposely seek positions of power over others. Their hatred of all things caring and social knows no limit. Despite suffering from cognitive dyslexia, pathological lying and a

complete inability to control themselves around people and money. Despite great efforts to maintain superficial appearances of normalcy, they cannot help but write who they are into policy, creating rules no caring parent would ever inflict on their children.

The psychopath removes the essentials of life, then provides temporary relief so their victim thinks there is hope. Attacks, withdraws, waits, attacks again without warning at any time day or night. Actively pushes people with no reserve energy left to walk into the night with no place to go. Saying here, go into the shelters. Then removes gear critical to survival, and the next night no shelter is available. Actively preventing people and groups with known solutions from saving those on the edge of death.

This will happen to anyone who does not have enough money for rent, is between jobs or can't work. Programmers, carpenters, seniors and high school grads to seniors, all are thrust into hellish circumstances far worse than found in any Canadian prison, which at least offers food, a bed, social programs, rest, exercise and education. This always happens when the mentally ill seize control of our lives.

All of this is easily preventable, but the Mayor and council, as the sole group responsible, are determined to let no one escape the bank-run land and housing model in which they are the major beneficiaries of collusive collaboration. This is not a Constitutionally valid basis of taxation.

The Mayor and council operate by removal of rights. I refer to signed contracts with bankers. Their brutalitarian policies of hate and death apply to an entire generation of young Canadians whose lives are at risk.

The Pioneer rights of each new generation to shrug off the worst practices of the past and use the best ideas across the planet to move forward. Their right to decide under Section 1 Charter

law how they wish to live. Their right to start a life from scratch and build it up by the labour of their own hands, free from this massive scale of illegal government interference in their lives. I refer to Supreme Court rulings, which this Mayor and council reject outright as they work against our lives, the law and the justice system, in full contempt for the lives of Canadian soldiers who fought and died for our freedoms. Some say we must not use the accurate descriptive language of the courts to say exactly what is going on, because it would not sound good. Some say this cannot be true, it cannot be happening, this is Canada and that sort of thing does not go on here. I spoke with a high school graduate on the street corner trying to save his toes with a look of shocked disbelief, not realizing that the fight to land his first job would also be a fight for his life.

As a direct result of the state of mind and beliefs of this Mayor and council, who resist and prevent all reasonable solutions, claiming the right to totalitarian rule over all of society, we now have camps where people die daily under the most horrific and miserable conditions. For the Mayor and council, this is the final solution and there can be no other.
