### **BUSINESS ARISING:**

- a) Update on Algonquin: Lyn reported that the manager is still away but she met with a delegate and signed the agreement. The expected number has been changed to 200. Lyn passed on to Carole, Myers package of Detailing and Cadillac weekend. She expressed disappointment that an additional cash donation will not be included and so Myers will not be eligible for corporate sponsorship recognition.
